

## House Sitting Policy

Palm Lake Resort accepts that Home Owners/Site Tenants/Residents have the right to engage house sitters to cover periods of extended temporary absence from Palm Lake Resort. This policy is intended to clarify house sitting arrangements and requirements.

- It is the responsibility of the Home Owners/Site Tenants/Residents to advise the Resort Caretaker/Manager of their proposed house-sitting arrangement in advance of their absence. House sitters must be in the opinion of the Resort Caretaker/Manager meeting a profile similar to the general resort Home Owners/Site Tenants/Residents population.
- 2. House sitters may be a maximum of two (2) individuals.
- 3. Home Owners/Site Tenants/Residents are reminded that they are not permitted under their Site Agreement/Lease to rent their home for a fee on a temporary basis during any absence.
- 4. It is the Home Owners/Site Tenants/Residents' responsibility to formally introduce the proposed House sitter/s to the Resort Caretaker/Manager who will complete a House-Sitting Form that records the details of the house sitter/s. The House Sitting Form will outline the following:
  - Home Owner/Site Tenant/Resident/s home number
  - Home Owner/Site Tenant/Resident/s contact details during their absence
  - House sitter/s full name/s
  - House sitter/s contact details
  - Commencement and end dates for the house-sitting period
- 5. The Resort Caretaker/Manager will provide the house sitter/s with a copy of the resort rules and/or Spirit of Community documents along with a general briefing on the operations of Palm Lake Resort.
- The Resort Caretaker/Manager will provide a notice informing all other Home Owners/Site Tenants/Residents of the home number and house sitter/s details along with the duration of their occupancy via an email.
- 7. The house sitter/s will have the right to use the Palm Lake Resort facilities subject to the same rules that apply to Home Owners/Site Tenants/Residents; however, they will not be entitled to participate in activities where Palm Lake Resort management is providing paid professional trainers or instructors.
- House sitters may participate in functions/events organised by the Palm Lake Resort Homeowner's Association, however where there is a maximum quota for a particular function/event then the house sitter/s participation in these events may not be at the expense of Palm Lake Resort Home Owners/Site Tenants/Residents.
- Home Owners/Site Tenants/Residents must notify the Resort Caretaker/Manager for all Home Owner/Site Tenant/Resident absences so that security and safety can be maintained within the resort at all times.
