2. The Redclaws drink voucher system is becoming unviable, with two bars and a larger population of bowlers and, in fact, is actually unlawful ie The Liquor Act. With this in mind, the Resident's Association has proposed a change. Redclaws will deposit money directly into the RA's bank account, which will become a Credit. When a voucher is redeemed at either Bar the sale goes to the Redclaws "voucher" code. Vouchers can be redeemed up to the value of \$3 (at present under review) and therefore cannot be redeemed for money ie therefore no change can be given. This new system is so much easier and can be used in both Oasis & Horizons bars. Also a simple bank transaction is preferable.

Upon discussion by the Committee it was agreed that the above proposal is the best way forward for all concerned. The new system will begin 1 September 2025.

3. The Redclaws voucher system is "open ended" ie no "use by date". It was agreed by the Committee that a use by date will be implemented. The current vouchers will have a use by date of 31 August each year. Could all outstanding vouchers please be used as soon as possible.

4. A verbel request for a separate FaceBook page be used by Redclaws for bowlers' use (same as Roamers). Upon discussion it was agreed that a separate FB page is not required.

All in favour.

5. A "Charter For Super Group" form from Jackie Davies, Resident's Association, was presented to the Committee. This proposal/form was rejected.
